**RODICA ALBU**, Professor of English Language, Linguistics and Canadian Studies at “Al. I. Cuza” University of Iași, Romania, is the author of *English in Canada. Representations of Language and Identity*, as well as the editor and co-author of *Canada anglofonă. Limbă și identitate/ Anglophone Canada. Language and Identity*; she has published articles with Canadian content in several journals and has been Romania’s representative in the Executive Council of CEACS since 2006. She is also the winner of the Canada-Europe Award (2008) as principal researcher of the project *Central Europe in Canada: Oral History Research*.

**JASON BLAKE** works in the English Department at the University of Ljubljana. He has recently published *Canadian Hockey Literature* with University of Toronto Press. He has translated widely from Slovenian, and is the author of *CultureSmart! Slovenia*, a guide to navigating the cultural mores of that country. His other recent publication is *Writing Short Literature Essays: A Textbook with Exercises for Slovenian Students*, which focuses on cross-cultural confusion in writing traditions.

**MICHAEL DEVINE** has a doctorate in drama from the University of Toronto and is Associate Professor at Acadia University in Nova Scotia, Canada. His doctoral thesis explored themes of strangeness and insularity in Newfoundland Drama.

**MICHELLE GADPAILLE** is Professor of English at the University of Maribor. She has published widely in a number of fields related to literature and culture, and is the author of *The Canadian Short Story* (Oxford University Press) as well as the more recent “*As She Should Be*”: *Codes of Conduct in Early Canadian Women’s Writing*.

**ALEKSANDRA V. JOVANOVIĆ** works in the University of Belgrade’s English Department. She has published a great deal in various fields of English literature, including analyses of the works of Alan Sillitoe as well as studies of intercultural issues in English studies. She is a member of the editorial board of BELLIS (Belgrade English Language and Literature Studies).

**JUDIT KÁDÁR** has taught American and Canadian culture studies at the Department of American Studies of Eszterházy College in Eger, Hungary for nineteen years, more recently with a focus on ethnic and multicultural studies. She has also published a textbook on Canadian literature (She published a textbook (*Critical Perspectives on English-Canadian Literature*, 1996). While her previous field of research focused on alternative histories and epistemological relativism in recent western Canadian fiction, she is currently exploring the epistemological, psychological and sociological implications of the gone indigenous passage rites (Othering) in Canadian and American literature and culture.

**JÁNOS KENYERES** is Director of Research and Associate Professor in the School of English and American Studies at Eötvös Loránd University, Budapest, where he teaches English and Canadian literature, Canadian cinema, and literary theory. He has several publications in these fields, including a book on Northrop Frye. From 2005 to 2008 he was Visiting Professor of Hungarian at the University of Toronto. He is currently president of the Central European Association for Canadian Studies, head of the Canadian Studies Centre in the School of English and American

Studies at Eötvös Loránd University, and co-editor of The AnaChronisT.

**TIHANA KLEPAČ** obtained her Ph.D. degree in the postgraduate program in literature, culture, performing arts and film at the Faculty of Humanities and Social Sciences, University of Zagreb, Croatia. Her dissertation was titled *Storykeepers: Australian Myth in the Works of Henry Lawson and Barbara Baynton*. She is a teaching assistant at the Department of English, Faculty of Humanities and Social Sciences in Zagreb. She has published in *Književna smotra*, *Umjetnost riječi* and *Studia romanica et anglica Zagabiensia*, and has co-edited *Irish mirror for Croatian literature: theoretical assumptions, literary comparisons, reception* with Ljiljana Ina Gjurgjan. Her research interests include white settler literature of Australia, and women's life writing.

**ÉVA MARTONYI** est professeur titulaire au Département de français de l'Université Catholique Pázmány Péter. She has published a large number of articles on Canadian literature and edited a book that approaches Canada that includes multidisciplinary approaches on Canada by internationally acknowledged authors from both sides of the Atlantic. Her main fields of interest are multicultural literatures in Canada and English-language writing in Québec.

**LUCIA OTRÍSALOVÁ** holds a PhD in Anglophone Literatures from Comenius University, Bratislava, Slovakia, where she is currently teaching Canadian Studies and American Literature at the Department of British and American Studies. Her research interests include black Canadian writing and history and Canadian transcultural literature.

**TOMÁŠ POSPÍŠIL** is Associate Professor in the Department of English and American Studies, Faculty of Arts, Masaryk University in Brno. He teaches American literature, American and Canadian film and American cultural studies.
